ALTERNATIVES TO LITIGATION

Subject to commercial wisdom, litigation shouldn't be given a complete go by if principally and constitutionally there is a strong case.

Admittedly in today's scenario Litigation is both a Costly and Indefinite process; which can be attempted to be avoided as far as possible.

In this scenario, Alternative Dispute Resolution processes should be taken advantage of:

1. Mediation (Section 89 & Order 10 of CPC);
2. Arbitration (Act of 1996)

LITIGATION IN LOWER COURTS/AUTHORITIES

- ❖ PRE LITIGATION CONSULTATION WITH AN EXPERT CAN PREVENT HUGE COSTS IN THE FUTURE.
- ❖ FULL & PROPER REPRESENTATION BEFORE AUTHORITIES/LOWER COURTS : A STRONG BASE GIVES ADDED ADVANTAGE IN CONSTITUTIONAL COURTS.
- ❖ IMPORTANT FACETS OF AN IN-HOUSE COUNSEL.
 - ❖ MASTERY OF FACTS
 - ❖ UPDATE IN TERMS OF VARIOUS NOTIFICATIONS/CIRCULARS ETC.

EXAMPLE: GST IS SEEING CHANGE IN LAW AS A REGULAR AND DAILY FEATURE, SO UPDATING YOURSELF WITH YOUR SUBJECT SPECIFIC INDUSTRY CAN BE A GREAT BOON AS AN INPUT WHILE PREPARING BEFORE A CONSTITUTIONAL COURT.
